COOPERATION AGREEMENT between

Consiglio dell'Ordine degli avvocati di Milano (Milan Bar Association), with offices at Via C. Freguglia 1, Milan, Italy, in the person of its President and legal representative, avv. Remo Danovi

and

Westminster & Holborn Law Society, in the person of its President and legal representative Coral Hill, President,
(together "the parties" or "the signatory organizations")

Recitals

- a) Milan Bar Association is an organization representing, in an exclusive and institutional way, lawyers belonging to the district of Milan (according to art. 25.1, of the Law December 31st 2012, No. 247, with its update, hereinafter the "Profession Act");
- b) Westminster & Holborn Law Society is one of the local law societies in London representing lawyers in England & Wales and located in and around Westminster and Holborn;
- c) between the signatory Law Society and Milan Bar Association a relationship has grown based on mutual hospitality and exchange of legal information, ideas and experience;
- d) the signatory Law Society and Milan Bar Association have now resolved to have a twinning agreement to provide

the following

1. The exchange of information and experience. In particular, the signatory organizations will reciprocally provide, and respond to requests for, information on the respective law and rules concerning the legal profession and legal system, in general; each party will also inform the other party of meetings, congresses, seminars, courses and training initiatives which may be of interest of the same;

2. the promotion and the organization of training seminars in areas of law of common interest; and
3. the improvement of contacts, the exchange of ideas and experience and the organization of networking as well as the organization of social events, such as visiting Courts, educational institutes and places of particular interest for the other party, attending various annual events.

The parties will consider and eventually organize training and internships in law firms selected by each signatory association for professionals, young lawyers or trainee lawyers sent by the other Party, on conditions which shall be agreed upon by separate agreement.
