



AGREEMENT

between

Seoul Bar Association

and

Milan Bar Association

Consiglio dell'Ordine degli avvocati di Milano (Milan Bar Association), with offices at Via C. Freguglia 1, Milan, Italy, in the person of its President and legal representative avv. Remo Danovi

and

Seoul Bar Association, with offices at 21, Beobwon-ro 1-gil, Seocho-gu, Seoul, 06595, Republic of Korea in the person of its President and legal representative Lee, Chan-hee (attorney at law)

(together "the parties" or "the signatory organizations")

Recitals

a) Milan Bar Association is an organization representing, in an exclusive and institutional way, lawyers belonging to the district of Milan (according to art. 25.1, of the Law December 31st 2012 No. 247 with its update, hereinafter the "Profession Act");

- b) The Seoul Bar Association (hereinafter "SBA") stands as the largest bar association in Korea representing all lawyer practicing in Seoul.
- c) Each association will solidfy the relationshop among the members and caters for their specialized interest through this Agreement.
- d) S B A has formed an international law section or committees practicing in foreign jurisdictions or otherwise becoming involved in international transactions while the Milan Bar Association has established among its members an "International Relations Committee" dealing with the continuing professional development and education of colleagues in the field of the international law and alike matters and assisting the Bar Council and its President in liaising with the other international bar associations.

The Parties, in order to develop and maintain a relationship based on mutual respect and co-operation, to strengthen the bonds and achieve cooperative development, now agree as follows

1) To maintain dialogue and mutual exchange of information about their respective legal systems.

In particular, the signatory organizations will:

- reciprocally provide information on the respective law and rules applicable to the legal profession, with particular reference to the rights and duties of lawyers, the organization of the Profession, the code of ethics and advocacy;
- respond to requests for information or consultation which may be made by the other Party;
- provide information on meetings, congresses, seminars, courses or study groups concerning international or comparative law matters organized by, or with the support of, the other Party and which have to do with principles, rules, rights, and duties inherent to the legal profession.

- exchange information on the law and orientation of the Courts in the areas of law of common interest; in particular to promote initiatives concerning international and comparative law:
- inform the other Party of training initiatives which may be of interest to that Party, due to their international or comparative law nature.
- 2) To cooperate in the protection of the role, the code of ethics and the rights of lawyers and of the institutions which represent them, assuming either a common position or the most aligned position possible, within international organizations and allowing common initiatives and measures concerning the interests of the profession to be adopted.
- 3) To mutually assist with the visiting to Court, Prosecution, and Educational Institute etc. when the other association visits.
- 4) To Promote the legal business communication and cooperation between the two organizations actively.
