Project Extention

Due to the coronavirus emergency, several events scheduled for spring 2020 had been cancelled. This forced the consortium to ask for an extension of the duration of the project. Following the approval by the European Commission, the end of the project has been postponed to September 2021.

The partners are currently working to restore the seminars. Next seminar, to be held in Burgos (Spain) on 23rd, 24th and 25th September, will be live-streamed. Seminars in Rome and Sofia are also planned in autumn 2020, participation modalities will be soon confirmed.
